## **ORGANISATION BACKGROUND**

KARRTABYA is a registered voluntary Non Government Organization. It was formed by a group of young people of Kalahandi in 1990. These youths were the members of village youth club; involved in various organizational and developmental activities of the village. They believed that social transformation could be brought through dedicated and committed work. Pursuing this, they worked to build up strength among the people of the locality and mobilized them to fight for social justice. This involvement gradually spread to other villages and became more comprehensive in nature. With the growth of understanding, their involvement became more matured and targeted towards various issues of the region. In due course of this involvement, KARRTABYA was formed. The organization is registered under SRA of XXI 1860 in 1992, under FCRA in 1998, 12A & 80G of IT Act.

## **OUR MISSION, VISION**

### **Vision:**

A developed society with more Peace, justice & equity in favor of poorest of the poor / down trodden of the society irrespective of Caste, Creed, Sex and religion.

### **Mission:**

The mission is "Sustainable socio-economic development through building capacities of the poorest sections of the society with emphasis on their greater involvement and participation in the processes of socio-economical, Political and moral development.

### **Strategy:**

KARRTABYA as a strategy believes in mobilization of people to build their strength, so that they can take up different issues of their own and fight. KARRTABYA just plays the role of a catalyst.

### **Goal:**

KARRTABYA has set the Goal to help people form a society, where the community is socio-economically well off and politically aware to create equal space for all its members to lead a life with dignity

### **Objective:**

The main objectives to be achieved through direct intervention in the situation are:

- Promote development of poor particularly of the tribal through proper mobilization of the community for adopting a self-sustaining and eco-friendly development strategy.
- Bring awareness among the ST and other unprivileged groups such as SC, small and, marginal farmers, landless and bounded labours to develop self reliance and social justice.
- Build up an institution base for training of tribal and other rural youth to develop efficiency and professionalism.
- Attempt total human development and social change in tribal and rural area through building up local level people's organizations.

## **OUR REACH**

KARRTABYA is operating in 7 Blocks of Kalahandi district viz. Junagarh, Dharmagarh, Koksara, Jaipatna, Kalampur, and Golamunda from **Dharamgarh Subdivision** and Thuamul Rampur blocks of **Bhawanipatna Subdivision** of Kalahandi district.

## OUR AREAS OF INTERVENTION

- **Education**

**Running of special coaching class for slow learners:** To ensure quality education, the Organization KARRTABYA has been continuing 3 Education supportive centers known as tuition centers in those areas where Govt. system is fail to reach. 128 children from Pipalguda, Dedara and Dainiguda got education through this education supportive centre. We have engaged 3 education volunteers to educate the children in regular school curriculum. The vulnerable tribal students are much more encouraged and excited to study in the centre. Pass out students are being mainstreamed to nearby Govt. school.

- ***Health & Nutrition***

KARRTBYA has worked with the support of UNICEF on Health, Nutrition and Hygienic development of the people of Golamunda block in the name of “SAMPURNA BARTA”. Especially we are working for pregnant, lactating women and children having increased nutritional status and access to preventive and curative health services from Health department in addition to we have improved the capacity of service providers to deliver quality of services related to infant and young child health, nutrition, child marriage and sanitation. This is a convergence programme with all line department where the partner organization and service provider work together to achieve the objective with the legal partnership with UNICEF beside that we work with the improvement of health & nutrition status of adolescents as well we developed their skill capacity to self sustained and motivate to the communities.



**Health Emergency Support:** One of the beneficiary known as child's siblings named Nilakantha Majhi of Katingpadar village who was struggling with his life due to snake bite on 13<sup>th</sup> August 2020 has recovered and became healthy with the emergency health support provided by KARRTABYA through ACC project. We are uses this fund only an emergency case.



**Routine Health Checkup of 100 CNCP children and their siblings:** This programme was conducted at Bandakutra, Dedara & Budhidara village where total of 144 children along with their siblings and 67 parents were treated by Dr. Bhagwan Panda

(Pediatric, CHC, Junagarh), Dr. Ankita Panda (Gynec specialist, CHC, Junagarh). Hemoglobin, Sick cell, Height, weight measurement & blood grouping facilities also provided to prescribed children.

**Training to adolescent Boys/ Girls on SRHR:** To acknowledging the incidence of stress, depression and other chronic problems in adolescent phase of transition of our culture and economy the training programme was organized by both for boys and girls in 4 units, where 129 adolescent boys and girls were got aware on Sexual reproductive health rights. The objective of the programme was to help the participants to develop, enhance and upgrade their knowledge on sexual reproductive health and rights.

**Orientation of Formal Health service providers on different thematic areas like child marriage, sanitation, nutrition, IYCF, responsive parenting, violence against children and COVID-19:**

We have organised 8 nos of Orientation training programme of Formal Health service providers(ASHA and AWW) on different thematic areas of Sampurna Barta at Golamunda, Uchalla, Kegaon, Mahalingh, Rengashapali, Brundabahal, Chapuria and Chichia where covered 315 front line workers. The objective of this training program was to provide better health service to the targeted group of Sampurna Barta project through ASHA and AWW and eradicate child marriage, malnutrition in Golamunda block and make the people of Golamunda block aware about COVID-19 through FLW.



**Community dialogue on adolescent issues at Sub Centre level:**

We have organised 20 nos of training program and cover 600 adolescent girls of different sub-centre of Golamunda block. The objective of this training was to reduce IMR and MMR hence we have created awareness about bad consequence, policy and laws of child marriage.

**Organized food festival:** The programme organized at Sankarpala and Dedara village where more than 200 participants were participated. Communities' people and children took part and aware about nutritional values of their local as well as the traditional food and its health benefits which surrounded in their areas which available and affordable. It was really a nice programme where the children and community people



actively participated and enjoyed. The objective of the programme was how to preserve the food for uses during the scarcity of food and educate them about nutritional value of food, maintenance of the hygiene. Children and community consumed lot of traditional well cooked food, forestry food and many more at a place and eagerly discussed about how they protect, harvest methodology of food preparation.

**Combating Child Marriage Issues:**

Child marriage brings bad consequence to physical, moral in every life of the human being that need to prevent to stable in healthy society. In fact it is ruin the Education, Health, Social and financial status of the

family as well as the society. No doubt it is a challenging matter for all of us but we fight altogether to remove from our society through awareness, motivation and with the help of legal aid.

Golamunda is a poor, migrant and drought prone area. Many migrants returned to their village when the lockdown was released all over the country due to the pandemic. Many wage labour people lost their livelihoods platform. Financial weak people started planning at their level to come out from this type of situation. Some poor parents started thinking of their daughter marriage. They thought that if their daughter gets married the burden will be released and their family member will be minimized. So they started to seek bridegroom for their daughter according to their financial condition. When they were getting a family who wants to finish marriage rituals at low cost and agree to take less dowry then the bride parents agree to conduct the marriage. When we got such kind of information from our operational area we reached that place with the line department without delay and stopped that activity and made parents aware about risk of child marriage. So far we are able to stop four child marriage cases in different sub center of Golamunda block such as Badchergaon, Dhamanpur, Daspur during this Covid-19 pandemic period.



It is an honor to say that all the information of above child marriage cases, we got information from our trained adolescent girls. It is the outcome of “Community dialogue on adolescent issue program” of Sampurna Barta project. Through this programme we have sensitized 3342 adolescent girls in Golamunda Block. They influenced by our programme and now they are strongly opposing child marriage in their villages.

**Panchayat level workshop with front line worker (ASHA, AWW, PRI, ANM, CMPO) on Prohibition of Child Marriage):** KARRTABYA had organized a Panchayat level workshop with front line worker on Prohibition of Child Marriage in 2 operational area of project where 98 participants were participated. Respective AWWs, ASHAs, Both adolescent girls and her parents, caregivers, PRI members were the participant of this programme, also the member of CWC, DCPU, respective child marriage prohibition officer, Chief Executive of KARRTABYA were the guest of this programme.

### **Livelihood:**

**Livelihood support to 5 families:** Provided livelihood support to five household among them one is kirana and the rest are gottery. Previously we had been provided with different livelihood support to 67 household and most of them are still continuing activities and getting better income. This is known as the ATM for the respective family because they are easily access the benefit.



**Training to the caregivers on goat rearing:** Under this ACC project, KARRTABYA is supporting to 72 families towards livelihood support and create the opportunity to generate income at their home. Based on this we have provided the goat rearing and management training as we identify the gaps and resolved at Sankarpala and Dedara. We have completed two units of training on gottery program, where 89 participants had participated. The objective of the program was to sensitize the caregiver families on proper care, rearing vaccination and shed management of goats so that the family can prevent the

mortality and earn better from goat farming which enhanced their family income and became able to provide better care, nutrition, education to their children.

### **Hybrid Seed Production:**

The small and marginal farmers are supported to increase their income. Total of 580 acres hybrid seed production program has done in the year 2020 – 21. There are 2 companies viz VNR Seeds and US Agri seeds have involved with us towards promotion of better financial and moral strength of the farmers.



### **Paddy Seed Production with NSC:**

To increase the income of the farmers KARRTABYA work in collaboration with NSC for production of certified seeds. Farmers get 20% more with MSP to involve in this program. Total of 54 farmers have been covered in 144 acres for seeds production. The farmers Procured 1532 quintal seeds which estimated cost is INR 3286140.00



### **Khariff DEMO –**

Dissemination of knowledge, technique, Technologies, Productivity and production we have demonstrated vegetable crops like new variety Crippling, onion, cabbage, Okra for closed farmers. Total of 7 DEMO have done through adoption of technology like IPM, INM, Mulching, Drip, Staking.

### **GIZ Project –**

Total of 400 farmers have surveyed for Micro Solar water pump project with the involvement of different archetype like Vegetable cultivation, Nursery, Nutri garden, Fruit Orchard, Poultry, Gottery, Diary. Water assessments of 7 different archetypes have also been done.

**Rojgar Divas and activities under taken in rojgar divas:** Rojgar divas organised in every Wednesday at all GP head quarter because all job card holders have to come to the GP in the day. Here discuss on identified problem and action taken for resolve the issues.. They know their labour payment and other activity of GP. all the staff has to be present because it is a mandatory to presence and replay their question answer After lunch of the project it is from Dec.2019 to Dec 2020 we are able to organise the 504 Rojgar Divas successfully where 1250 members were present. These are the following discussed about for the clarity of the target group.

- Daily wages
- Field level problems.
- Consequence of Migration.
- PD generation
- Activity of NRM.
- Activity of Non NRM
- Timely payment



**Village and GP level community sensitisation event:-** Sensitization meeting conducted to create work of MGNREGS . Job Card holders, Gaon Sathi, Word members, Sarpanch, GRS, CM, BFT and JE have to participate in the scheduled meeting. People of the particular village are involved in the discussion and planning also they are provide their opinion for smooth implementation of the program.

**Implementation of livelihoods supporting activities and other NRM activities:**

NRM works are available in the entire retinue village as like the tank, TCB, ST, LD with 5% Model etc. In addition to the target group has to be provided for Individual livelihood support toward construction of Cow shed, Goat shed, Piggery shed, Poultry shed.



**Identify of vulnerable children & Financial support to the care giver**

**family:** We have total of 100 needy children with in our project have gotten support of Rs. 1000/- per month through Bank Account. 100 CNCP children along with their siblings got immediate benefits through financial help and enjoyed homely and safely environment.

**Vocational training to the Girls children:** This skill training we have conducted at our project village through the support of Alternative form of child care project to strengthen the sewing skill of the girls children to generate income at their home and support to their family needs. Al most we have completed 6<sup>th</sup> batch training where 120 girl's children were availed the scope. Right now they are self sustained.

- **Strengthen of Community Based Organization on different laws and policy of child rights and Protection:**

**Village wise training to the parents on Parenting Skill:** Parenting skill is most important to carry out the development of children. Based on this we have conducted 20 unit of the training programme at in different operational area of the project to reinforce positive parenting practices and empower parents to address the challenges that they face in bringing up their child. 600 parents were trained up on how to care, protect children and how can they make a decision for a better future of their child and become good parents.

**Capacity building of VCPC member on Child Rights & Protection:** 1 unit program has been completed where 58 VCPC members were participated from different VCPC. 58 VCPC members from different village-level child protection committees are developing their capacity on child Rights and protection.

**Half yearly VCPC Review Meeting:** Completed 2 nos of programmed where 68 participants involved in this process. The committee members were involved in the process and shown their greater involvement in identifies and checked the child related issues.

**Strengthen the PLCPC on child rights & protection:** We have completed 4 nos. of PLCPC meeting at different location of the project. The totals of 88 PLCPC members were participated and got knowledge on child rights and protection policy. They are proactively identified the child related issues and resolved at their level.

**Developing IEC material on Child protection:** IEC material on child marriage had been developed and disseminated in different villages within district through different programme.

**Child Development:**

**Half yearly Child club meeting: 2 units have covered in this year.** We have completed the two unit child club meeting where all child club leaders gather at one place and share their ideas, views and exchange their innovation. We guide them in their decision making and how they utilize the resources.

**Panchayat level training with child club leaders on Child migration tracking:** As planned 4 units of Panchayat level training programmes to child club leaders on child migration have completed where 196 child club leaders trained up.

**Strengthening of Child club leaders on child rights:** 1 unit of program at Dedara village have completed where 46 child club leaders were participated from different child clubs. Child Club leaders were aware about child rights through this training. They also aware and develop their leadership skill, managerial towards child rights through this training.

**Identification, capacity building and engagement of volunteers in social mobilization at community level.**

We have organised 4 capacities building training program for the community volunteer at Rengashapali and Kegaon Golamunda and Rengashapali. 100 Community volunteers from 20 different sub-centre of Golamunda Block participated in the training program. The main objective of this program is to create awareness among the community volunteer about positive health behaviour. Create awareness about the risk of child marriage and benefits of toilet use in the community through the community volunteer.

**Celebration of Anti-Child Labour Day-** Rallying by the community to stand up for Girls' Rights: we have conducted 4 units of awareness programme as targeted on Anti-Child Labour Day at different places with an objective to sensitize the community people to prevent the practice of child labor and empowering them with the power of education. Children from different child clubs approximately 209 were attended in the programme beside that different stake holders such as PRIs, SHGs, VCPC representatives, ASHA workers, AWWs, Parents, care Givers, village leaders, youth leaders were involved and shown their interest to educate their children.

- **Youth Empowerment through skill Development:**

**AE Training -**

Our main aim is to help poor farmers by adopting modern production technologies for better productivity and higher income. So our organization supporting the farmers in bringing improving their technical knowledge and farming system under our Agri Entrepreneurship Program. The Agri Entrepreneur Program, we selected the drop out rural youth by different selection process and trained them to be a successful AE and serving the nearby farmers and also generate some income. Due to Corona Pandemic, it has been decided to start the 36 days training program through online mode. The candidates those are successfully completed the training program awarded by NIAM (National Institute of Agricultural

Marketing) certificate. We successfully completed 03 batches virtually and trained 87 candidates in the year 2020-21.

### **Agri. Entrepreneurships Development.**

We have worked with 129 AEs in different Archetypes like Agri Input, Agri output, Seed Organizer, Digital banking, Nursery, Farm Mechanization and having their turn over INR 81479645.

### **AgriPos.**

AgriPos is an application on which AEs are generated demands for their business. Due to Corona Pandemic by using AgriPos app our AEs generate their demand for seeds, fertilizer and Pesticides for input linkages. There are 48 AEs involved in this process and actively expedited their activities.

### **Digital Banking & Gram Cover Insurance.**

With the motto of 'Sat Pratisat Digital', we accelerated our AEs to do Gram Cover Insurance and Digital banking to generate some additional income. For that purpose, we created ID for Digital banking & Gram Cover Insurance and conducted training through ZOOM. Total 28 AEs were involving on this archetype.

**Engagement of Mate:** - Mates are engaged in every revenue village hence they are directly contact to the Job Card holder. One mate able to engaged around 40 labour in their community and they are received the sum of total remuneration for unskilled payment.

**PIM:** PIM means Project Initiation Meeting. Any project would be start there is mandate to organise a village level meeting, where all Job Card holders would come to the meeting and Open house discussion with them on payment process and smooth management of work.




**Covid 19 insurance for AEs** – Covid insurance of 38 AEs have been done


A. **Capacity Building of Cadres:** GP level cadgers play the vital role in MGNREGS working process, based on this we have conducted the capacity build training for them hence they were actively involved in the NRM and Non-NRM works. In the scheduled training, respective GP level cadgers like JEs, GPTA, GRSSs, CMs, and Mates were capacitated.

B. **Participatory planning process:** After the village planning meeting through people participation, they are able to identify their village resource and mapping of activity.

C. **Social Map:** Social map has to be reflected the village resource and data available there.



Particularly this map has prepared through community participation. This is the process of community participation. 71 nos. of Village Social Map has been prepared by village people.

D. **Resource Map:** resources map has to be reflected the resource available in the villages. This map also has to be prepared by the villagers. In FY 2020-21 71 nos. of Resource Map prepares.

E. **Transit walk:** Transit walk means journey by foot before collect the data to understand the situation of the village. Initiation of the every developmental work the investigator move the village site & out site of the village for observation of this village also they will get the idea on the land pattern. After completion of transit walk they has to summon the community meeting for rectify the data and do accordingly as per the suggestion of the people.

F. **Need based contextual planning:** Based on the demand of work and to engage more nos. Of labour, the implementation personnel has planned and segregated the work as of 75% NRM and 25% Non-NRM work during the GPs level planning process.

G. **Annual action plan:** Annual Action Plan in the FY 2020-21 have been developed at all GP where 5578 project and Additional Action Plan for the FY 2020-21 also been developed where 1580 project have been placed in the GP level planning process to ensure the job security at community level.

- **Coordination and Convergence with Line Department:**

**District level Sensitization programme on" One step towards Elimination of Child Marriage":** Sensitization programme on "One step towards Elimination of Child Marriage" among the stakeholder were conducted at Jaypatna Block office premices. 87 front line workers such as ASHA, AWW, PRI representative, different CBO's, SHG members, teachers, lecture, Media were the participant. Repetitive from CWC, DCPU, JJB were participated. The respective Block Development Officer was the guest of the programme.



**Block level workshop on Child Rights & Protection:** 3 Block level workshop was conducted by KARRTABYA at 3 blocks of Kalahandi district such as Junagarh, Dharamgarh and Koksara Block where all front line workers from respective blocks were participated

**Planning, monitoring and review meeting process and documentations:** Expedite the works man days, the working process has been developed in a quality manner. Before the entry point activities we developed area based focused plan with block as well as the GP level officials. All the block officials and NGO representatives were involved in the process. Based on the work plan, monitoring visits has executed by respective block and NGO representative and drawn their feedback to the respective working staff for

further improvement. Track the progress of the work, block level review meeting has conducted in regular interval and kept the document in every aspect of challenges and achievement.

**The orientation workshop for NGO staff, Key Dist/Block Functionaries was a convergence program with the line department of Golamunda block.**

We organised this program at Golamunda block. The Medical officer, PHEO, CDPO, ICDS Supervisor, ANM, JE RWSS, BDO Golamunda, Project staff of Sampurna Barta and C4D specialist UNICEF Mr. Santosh Behera were involved. The objective of this program was needed support, co operation and proper guidance of the block administration towards the success of Sampurna Barta project.

**One day Block level training of PRI members and PEOs to ensure health monitoring at GP level through GPRS.**

We organised 2 training programmes of PRI members and PEOs. 28 PRI member and 28 PEOs participated in the training programme. The objective of this training program is to convergence and active support of PRI members at GP to block level and make aware the PRI member to monitoring the VHND and immunization session and mobilize the high risk patent towards intuition at sub center and village level. Sensitize the PRI member to stop child marriage in their responsible. Panchayat level members could be monitoring the migrants and make aware the people about COVID-19.



**Other Activities:**

The entire world was suffering and going through a hard-hitting situation due to the pandemic COVID-19. In this difficult time, everyone needs to stay at home to break the corona chain, KARRTABYA trying to disseminate the necessary information to the children as well as the community people through different mediums without failing to meet the guidelines issued by the Govt. regarding COVID-19 Lockdown.

**Awareness for Social Distancing-**

Social gathering is being seen in many places in our operational area like work side of MGNREGA, PDS distribution side, THR distribution side, Cooked meals distribution side, VHND and Immunization points. The project staffs of KARRTABYA give their best effort to convince and making the people aware about importance of social distancing in time and advice them to maintain social distance in those places. The staff's along with PRI member and front line worker are trying to stop this type of social gathering and making them aware the important of social distancing during these critical periods.

**Hand wash demonstration-**

The project staffs are and the front line workers such as AWW and ASHA are demonstrating hand wash at household level, where the parents, children and community person and migrant people are being demonstrated with proper hand wash technique with soap and liquid soap for twenty seconds. So far we have conducted 519 hand wash demonstration at different villages and different TMC of



Golamunda block and able to covered more ten 10000 people of our operational area. During the hand wash demonstration we are explaining the benefits of hand wash to the rural people and advise them when we should wash our hand. Following are the key points of the training programme:

- Why Hand wash is important?
- When we should wash our hands (before/after)
- Steps of hand washing

Covid - 19 Awareness campaign: To aware the farmers associated with our organization we involved our AEs to aware about the Covid-19 through call. Total 51 AEs covered in this campaign with 8688 farmers covered

**Role of PRI members in NH Activities:** Some of the active PRI members sensitizing the pregnant and lactating women about the prevention of covid-19. They are explaining the benefits of IFA and calcium tablets to pregnant women about the risk of home delivery and benefits of institutional delivery. They are requesting the pregnant women to stay 48 hours in hospital after delivery. Advise them to attend the immunization and VHSND session regularly.

**Role of Adolescent girls:** Some of the active adolescent girls of our clubs are making awareness in the village to pregnant and lactating mother about the prevention of COVID-19. They are visiting door to door of their village and sharing the method of prevention of Corona virus. They are requesting to the pregnant and lactating mother to stay at home. They are advised them to avoid huge gathering. They refused them to go to the weekly market and advise them to maintain the social distance and stay at home during VHND and immunization point. They demonstrate hand wash technique with soap and advice them to wash hand frequently. They requesting to the entire villager to report any suspicious case and flu to the Health staffs, AWWs, nearby PHC or CHC for better treatment.



### **Awareness about COVID-19 Vaccination**

We have good coordination with NRHM Golamunda and also the Block administration, So that the Govt. Official of the block has been sharing the different issue with us towards resolved. The PHEO & MO, CHC Chapuria and Junagarh were sharing the details about the low coverage areas of the COVID-19 vaccination regularly with us. Soon after getting the information we reach the village and organizing awareness meeting. In the meeting we are making the people aware about risk of COVID-19 disease and importance of vaccination through community influencer, PRI member and Front line service provider through uses of sound system. KARRTABYA staffs were supporting the medical team at the sub center level COVID-19 vaccination. So far we have vaccinated 652 helpless people by taking them to the vaccination center.





Outcome- Now the people of Golamunda and Junagarh block are habituated into the prevention of Corona virus. They are adopting the prevention method like using mask, hand wash practice and social distancing. They are taken all this activities in their daily routine. People are using mask at the time of leaving home, in the time of collecting water and they are washing their hand frequently. Now the people of the block are going to the CHC and PHC for their vaccination without any hesitation.

### **VHSND and RI session challenges during COVID-19 period**

VHSND and RI programs are playing a vital role to minimized IMR and MMR. Due to the threat of the pandemic beneficiary were unwilling to attend the programs. After regular home visit and counseling by our project staff beneficiary had been agreed to come to the center for get the required services. During this lock down period of 2020 we have attended 612 VHND and 306 immunizations at different sub center of Golamunda Block and identify 137 high risk pregnant mother and 64 under Wight children in the VHND and immunization session. We are counseling our high risk group of beneficiary about health and nutrition for their betterment.

This terrible situation continued till the month of October. After October the situation have gradually return to normal. Keeping view the situations the Govt. of India allow the economical and social activity. After that we started our budgeted activity by following Govt. guideline.

**Monthly Staff review Meeting:** Monthly staffs meeting have been organizing on regular basis for analysis, monitor the planned activities for smooth functioning and achieving the project goal, where any deviations of the programmed the team are critically discussed and developed strategic plan for smooth running of this programme in every month.

**Training to organization staffs on child protection policy.** KARRTABYA organized training programme to its staff on Child Protection Policy through SKN where 39 participants from the organization staff, GB members, volunteers were participated in the training programme to aware about the policy and norms. To protect the child from any type of abuse, violence, exploitations, promote a child friendly culture where everyone is committed to keep the children safe which we encouraged during the training.

**Distribution of Survival Kit (COVID Support) :** COVID-19 has broken out as a worldwide pandemic situation and impacted every sector of the life. The situation ruined the livelihood, Health, Education hence peoples are suffering mentally, financially. They have lost their livelihood especially it is impacted the poor in rural and hilly area. They have no alternative to do some things and support their family needs. Keeping view in mind KARRTABYA has initiated a plan to provide the emergency ration and survival kit support to the community of hilly area of Junagarh block. KARRTABYA thinks to do something to minimize the stress of the community at least the community would able to thinks about the near future and seek the job opportunity within the support .Hence the organization started the identification process and requested to Ajim Premji Philanthropy Foundation to provide the ration and emergency materials support. This could be successfully approved and sanction by APF.



**Selection of target groups:** A door to door survey had been conducted through our team members with physical verification and study the need of the family. We had found almost 500 House hold during survey. Really the household had needed an emergency support because COVID has ruined their livelihood. Almost we have distributed the survival kits to 671 household with the support of local youth, PRI members, AWW, ASHA and line departments successfully. We saw the smile face of the communities during the pandemic situation at very closed.



**Create platform for Intern Student:** KARRTABYA not only works for the rural deprived people but also create platform for professional students. This year many students from different Institutions like:- OUAT, Centurion University, KIIT University and Kalahandi Universityt opportunity for practical learning from our operational Area.
